The warranty covers defects of construction, production and faulty workmanship for a period of ONE (1) YEAR.


The warranty is valid from the date of delivery to the first owner ("Warranty Period").

SaVeri Singapore Pte. Ltd published guidelines include, but are not limited to information stated in material specifications, user manuals and maintenance guidelines.

SaVeri Singapore Pte Ltd is not responsible for damage arising from failure to follow instructions relating to the SaVeri ® product's use, maintenance guideline and user manuals.

- 1. This declaration does not affect any right and obligation from the Buyer to the Seller and reverse agreed in the sales contract.
- 2. The warranty declaration of Saveri Singapore Pte Ltd is valid insofar it is not against the current national law of guarantees.
- 3. SaVeri Singapore Pte Ltd grant a product warranty for Saveri® products, confirmed in individual Order Confirmation or accepted Purchase Order. Warranty period is starting with the date of transfer of ownership.
- 4. With the claim, the original purchase agreement or the invoice has to be shown
- 5. In case of any claim, which is included in the coverage, SaVeri Singapore Pte Ltd keeps its right to repair or replace the product or issue a credit note.
- 6. In case of an entitled claim, the replacement will be sent carriage free.
- 7. In order to ensure, that the claim is entitled, a written notice has to be sent immediately after the damage occur. Use only the contact e-mail, stated in article 16.
- 8. The detailed description of the problem, an overview photo as well as a detailed photo is required for the evaluation. (overview photo taken of a distance of 2-3-meter; detailed photo 0.50-0.70-meter distance)
- 9. In case of transport damage, the original carton needs to be stored until the claim is approved. The damage notice given to the carrier has to be submitted.
- 10. We grant warranty and product liability for 1 year in correspondence with
 - a) our material information
 - b) our assembling instructions
 - c) our take care information
- 11. This Warranty does not apply:
 - a) to the protective coatings that are designed to diminish over time, unless failure has occurred due to a defect in materials or workmanship
 - b) to cosmetic damage, including but not limited to scratches, color variation
 - c) to damage caused by the wrong use with another product/plant
 - d) to damage caused by accident, abuse, misuse or other external cause

- f) to a product that has been modified to alter functionality or capability without the written permission of SaVeri Singapore Pte Ltd

- j) if the product ID number and or the Saveri® imprint/logo has been removed or defaced from the SaVeri® product

- m) damage cause by transport and claimed later than 3 days after receipt
- n) damage through force majeure or any other reason out of SaVeri Singapore Pte Ltd responsibility
- 12. We grant only this warranty to our direct buyer (first owner) of the product. The warranty cannot be transferred further.
- 13. Warrantees do not extent the warranty period
- 14. Additional terms apply, if the first owner is the end-user of the product.
